This is a Star FITA Outdoor Tournament.

The tournament will be held at the Plymouth Street Recreational Facility, on Plymouth St., Mansfield, MA.

Awards will be presented on Sunday, August 21<sup>th</sup>, after the tournament is completed.

All competitors must be members of the NAA or NFAA.

The tournament is a FITA Outdoor round and consists of a 144 arrows shot in four distances with 36 arrows per distance. **(Compound archers are shooting four distances.)** The longer distances will be shot on Saturday, August 20<sup>th</sup>, the shorter distances will be shot on Sunday, August 21<sup>th</sup>. All competitors will shoot at a FITA 122 cm target faces for the longer distances and FITA 80 cm target faces for the shorter distances. FITA Constitution and Rules and USA Archery Dress Code will be strictly observed for all competitors.

There is Official practice on Saturday, August 20<sup>th</sup> and Sunday August 21<sup>th</sup> from 8:00 am to 8:45 am.

The tournament starts at 9:00 am on both days, Saturday August 20<sup>th</sup> and Sunday Jun 21<sup>th</sup>.

**Follow Rt. 140 North until you reach the first light and take a left onto School Street.**

**Continue on School Street then at the 2nd light take a right onto Plymouth Street.**

**The Plymouth Street Recreational Facility is located about 1/3 mile down on the left. When you enter the 1<sup>st</sup> parking lot, turn left onto the access road and follow the access road until you see the venue on your right.**

**Rte. 495 South exit 12, go right onto 140 North**

**Follow Rt. 140 North until you reach the first light and take a left onto School Street.**

**Continue on School Street then at the 2nd light take a right onto Plymouth Street.**

**The Plymouth Street Recreational Facility is located about 1/3 mile down on the left. When you enter the 1<sup>st</sup> parking lot, turn left onto the access road and follow the access road until you see the venue on your right.**

**Rte. 95 South take exit 7, go onto 140 South**

**Rt. 140 South until you reach the fifth light and take a left onto School Street.**

**Continue on School Street then at the 2nd light take a right onto Plymouth Street.**

**The Plymouth Street Recreational Facility is located about 1/3 mile down on the left. When you enter the 1<sup>st</sup> parking lot, turn left onto the access road and follow the access road until you see the venue on your right.**
